



# Aurora Global Income Trust (ASX Code: AIB) Performance Report - February 2014

## Summary

- In one of its best months the Trust returned 3.3% which outperformed the UBS Bank Bill Index
- A high percentage of trades were profitable with Consumer Discretionary and Utilities standout sectors
- A reduction in US Federal Reserve policy speculation has helped increase the efficacy of the strategy

The above composite/hybrid performance summary reflects a combination of the performance of the investment strategy as it applied (net of fees) within the former Aurora Sandringham Global Income Trust (ARSN 131 291 499 - now terminated) since its inception in July 2008 to 30 November 2010, and then the performance of this Trust (which implemented the same strategy) since 30 November 2010 to date. This is not the actual performance of Aurora Global Income Trust (AIB). The actual return of AIB since inception is 2.9% p.a. The table above and the charts below refer to the performance of the composite/hybrid strategy and not of the actual performance of AIB.

#### Investment Objective\*

To provide investors with steady income returns after fees and expenses in excess of the UBS Australia Bank Bill Index over rolling three year periods while protecting their capital. Please note that while we aim to achieve this objective, the returns are not guaranteed.

#### Portfolio Commentary

Global markets recovered from a weak start to 2014 by delivering strong returns in February. Most major economies displayed resolve despite nervousness of a slowdown in Asian growth, in addition to the political turmoil emanating out of the Ukraine. Catalysts for the surge (US Dow Jones: +4.0%; UK FTSE: +4.6%; German DAX: +4.1%) included robust quarterly US earnings and a general confidence that the global economy will continue its recovery.


From a trading perspective, February was one of the strongest months in the Trust's history, in which it returned 3.3%. Undoubtedly, the reduction in Federal Reserve policy speculation has aided the strategy as market participants return their attention to company results. Statistically, the average outperformance per trade was 0.67% with the strongest returns realised in the Consumer Discretionary (2.3% outperformance per trade) and Utilities (3.2% outperformance per trade) sectors.

Companies which contributed favourably to performance included O'Reilly Automotive (+13.0% outperformance) and Weir Group PLC (+12.7% outperformance).
