

Aurora Global Income Trust (ASX Code: AIB)

Performance Report - January 2014

Summary

- The Trust returned +0.2% in January 2014 which matched the performance of the UBS Bank Bill Index
- Utilities and Health Care were our most profitable sectors; Materials and Energy trades detracted from performance
- The Federal Reserve continued to taper its bond-buying program despite global market volatility

The above composite/hybrid performance summary reflects a combination of the performance of the investment strategy as it applied (net of fees) within the former Aurora Sandringham Global Income Trust (ARSN 131 291 499 - now terminated) since its inception in July 2008 to 30 November 2010, and then the performance of this Trust (which implemented the same strategy) since 30 November 2010 to date. This is not the actual performance of Aurora Global Income Trust (AIB). The actual return of AIB since inception is 2.4% p.a. The table above and the charts below refer to the performance of the composite/hybrid strategy and not of the actual performance of AIB.

Investment Objective*

To provide investors with steady income returns after fees and expenses in excess of the UBS Australia Bank Bill Index over rolling three year periods while protecting their capital. Please note that while we aim to achieve this objective, the returns are not guaranteed.

Investment Strategy

To take advantage of global companies that Aurora expects will increase in value relative to the market around the announcement of their quarterly, half-yearly and yearly earnings results while hedging their market and currency exposure.

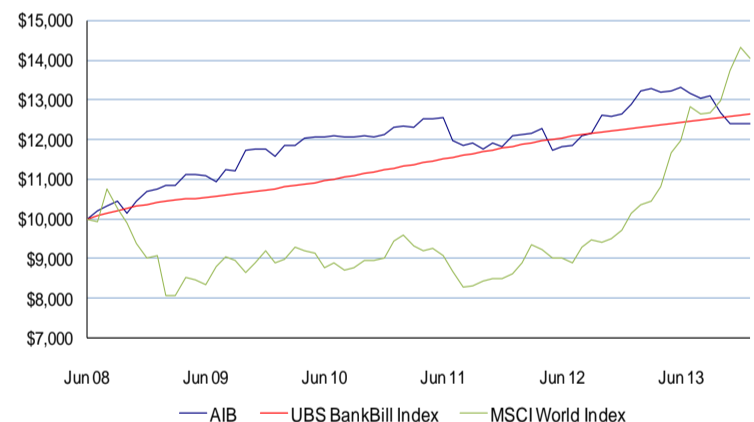

Portfolio Commentary

Global markets began 2014 in a consolidation phase prior to a sharp downturn, following an extremely profitable 2013. Focus turned towards a surprisingly sombre read on China's manufacturing sector as well as the ramifications of the Federal Reserve's withdrawal of stimulus measures from the economy. These drivers resulted in a sell-off through late January as investors reallocated funds away from equities to safer asset classes, such as bonds.

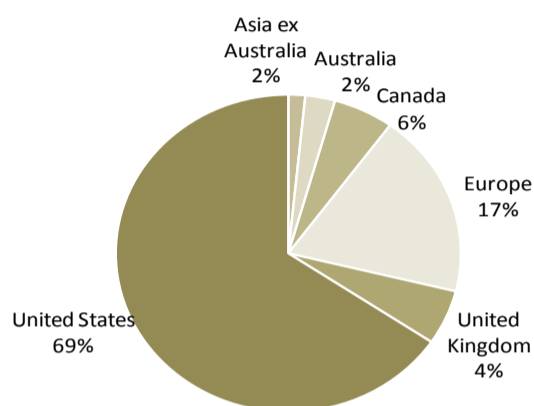
From a trading perspective, January was a better month for companies releasing earnings compared to the previous quarter. For example, estimates from a leading data provider indicate that 72% of the companies to release results in the US had reported earnings above the mean estimate, which is well above average. Furthermore, a reduction in broad-based market rallies due to Fed policy speculation (where poor economic data often heightened the likelihood of stimulus retention) and a renewed focus on company earnings increased the efficacy of our strategy, which is what we expect throughout this year.

Dow Chemical (+9.7% outperformance) and PNC Financial (+8.9% outperformance) were two profitable trades.
