

# Aurora Dividend Income Trust Performance Report - October 2014



# **Summary**

- The Trust rose by 2.5% in October while the market rose by 4.4%.
- October saw strong performances by financials, telcos and healthcare companies and strong underperformce by resources.
- The Trust marginally outperformed with gains in these positive sectors being largely offset our resources holdings.

#### Objective

The objective of the Trust, relative to the Australian equity market, is to provide investors with:

- greater total returns over rolling 5 year periods;
- more income and franking credits each year; and
- · less volatility.

The Australian equity market is measured by the S&P/ASX 200 Accumulation Index adjusted to include franking credits.

#### **Distributions**

The Trust distributes at least 0.5% of net assets in cash per month. In addition, the Trust distributes franking credits monthly.



## Commentary

Global equity markets approached October with the usual trepidation associated with a month that produced some of history's largest sell offs. However American and Asian markets generally produced positive returns (Dow Jones +2.0%, S&P 500 +2.3%; Nikkei +1.5%, Hang Seng +4.6%), but concerns around German economic growth saw weaker returns from European markets (FTSE –1.2%, DAX -1.6%).

The S&P/ASX 200 Accumulation Index rallied 4.4% rebounding from September's sell-off. This rally was largely in high yielding industrial companies (Financials +6.9%, Telcos +6.0% and Healthcare +6.4%), whilst a 11% fall in the oil price and ongoing concerns about commodity prices saw flat or negative returns from most major resources names. As the Trust is long both these sectors, their differing fortunes largely offset each other with the net impact of 0.2% outperformance over the month.

Since inception, the Trust has returned 7.6% p.a. which is marginally below the underlying market. Relative to benchmark the Trust has outperformed by 2.0% per annum.

## Notes:

- 1. The returns describe the consolidated returns after fees of the Trust and the Aurora Sandringham Dividend Income Trust (ARSN 108249 154, 'ASDIT' established 16 November 2005). They assume the reinvestment of distributions and franking credits. The performance references against the S&P/ASX 200 Accumulation Index plus the value of franking credits as determined by Aurora. The investment strategy of these trusts were modified on 31 December 2010.
- 2. The Trust intends to always distribute at least 0.5% of NAV in cash plus any available franking credits, per month regardless of performance. This means that if there is insufficient net income in a given month, investors may receive a partial (or full) return of capital.
