

# Aurora Property Buy-Write Income Trust Performance Report - May 2013

ASX Code: AUP

## Summary

- The Trust returned -1.09% for May compared to the S&P/ASX200 Property Accumulation Index (AREIT Index) which returned -3.72%.
- Since inception, the Trust has outperformed the S&P/ASX200 Property Accumulation Index by 7.10% per annum.

## Investment Objective\*

The Aurora Property Buy-Write Income Trust (the Trust) is an ASX listed investment trust that aims to generate income from an active strategy of selling call options over a portfolio of ASX listed Australian Real Estate Investment Trusts (AREIT).

APN FM is an active investment manager with a concentrated focus on income and the fundamentals of real estate.

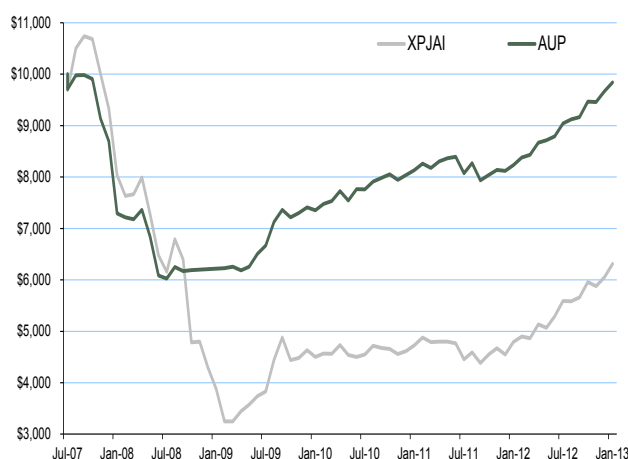
APN FM has a long held belief that investment in commercial property is primarily an investment in an income stream. Long term property leases also provide protection from the short term business cycle reflected in the market value of other asset classes. A commitment to the income benefits from property coupled with a lower level of risk (as measured by volatility) is reflected in APN FM's style of investment which focuses on well managed property assets that hold long leases to strong tenants.

The APN FM investment team comprises a group of highly experienced real estate investment professionals who possess a deep understanding of real estate markets gained over several cycles.

APN FM's conservative style is underpinned by rigorous research, a proven investment process utilising a "top down" and "bottom up" approach, wide industry networks and assessment of market fundamentals. ## Commentary

The Aurora Property Buy-Write Income Trust (AUP) was down 1.09% for the month strongly outperforming the AREIT Index down 3.72%

The covered call strategy was the main reason for the outperformance by the Trust. The AREIT Index outperformed the broader market (as measured by the S&P/ASX 200 Accumulation Index) which returned negative 4.5% over the month. In the last twelve months, the AREIT Index delivered a total return of 30.8%, outperforming the broader market by 4.3%.

The Diversified sector was down 5.0% over the month. Mirvac Group (MGR) (down 5.4%) and Stockland Trust Group (SGP) (down 5.7%) were the two key stocks influencing the sectors performance.

The Office sector was down 4.1% over the month with Commonwealth Property Office Fund (CPA) (down 5.2%) and Investa Office Fund (IOF) (down 2.7%) the key drivers.

The Retail sector was down 3.3% with CFS Retail Property Trust (CFX) (down 8.6%) and Westfield Retail Trust (WRT) (down 6.7%) the two significant factors over the month.

In the news:

- MGR raised \$400m of equity to fund the \$584m GE office portfolio acquisition on a 7.8% initial yield.
- SGP raised \$400m of equity and intends on using the proceeds to initially reduce debt then fund its development plans.
- GPT Group (GPT) withdrew its proposal to acquire ALZ's commercial and industrial business, citing pricing issues as the main reason.
- In a very well supported equity raise, Cromwell Group (CMW) raised \$250m to fund the purchase of a \$405m portfolio from the NSW Government on a 9.0% yield.
- Dexus Property Group (DXS) acquired the premium-grade Kings Square, Perth development with its wholesale fund for \$434.8m.
